4-H Horse Project Requirements and Activities

4-H and FFA members participating in the Horse Project must have **ALL HORSE(S)** identified that you intend on exhibiting at their respective County Fair and/or the NCK District Horse Show. These forms need to be post-marked or dropped off to your local Extension Office by **May 1, 2022**. You can find these forms at your local Extension Office or on our website at www.rivervalley.k-state.edu. Our recommendation is to submit identification on more than one horse, if available, in case of injury.

NOTE: Each horse has one identification form for its lifetime; you may submit your form from previous year(s) if you intend to compete with the same horse in 2022.

You can find a copy of the Kansas 4-H Horse Program Rule Book at your local Extension office or on the River Valley District website. The rules and patterns used at your respected county fair and/or NCK District Horse Show are located in this book. If you have any questions, you can contact your local club, county Horse Project Leader or your local Extension Office.

Horse Project Activities Calendar of Events:

Open Horse Judging Contest – (March 18) Kansas Horse Council is hosting a great practice for those individuals wanting to attend the state contest. This event is combined with Equifest; Salina, KS.

Horse Judging Camp – (June 7-8) The Camp is open to 4-H and non 4-H members who want to practice their skills for the state contest. This event is held at Kansas State University; Manhattan, KS.

State 4-H Horse Judging Contest – (June 9) Registration for this event will be available in April. Your local Extension Office will make sure that club and county project leaders know when that is available. This event is held at Kansas State University; Manhattan, KS.

NCK District Horse Show – (June 21-22) Those 4-H members who want to take their Horse project to the Kansas State Fair, **must compete in this event or one similar**. You will need to complete Level I testing, which can be found on the River Valley District website. If you have any questions, please contact your local Extension Office. This event will be held at Saline County Livestock & Expo Center; Salina, KS.

4-H Youth Attend Citizenship in Action in Topeka

Fourteen 4-H'ers and three chaperones from the River Valley District attended Kansas 4-H Citizenship in Action, (CIA), in Topeka on February 20 and 21. This statewide event is for older youth to learn how the legislative process works and how their local voice and participation in decision-making can make a difference in our local community.

Sunday afternoon, 4-H'ers were split into small groups to listen and deliberate two different mock bills that they would later debate. Sunday evening, 4-H'ers attended a formal banquet with Representative Lisa Moser from District 106 as our River Valley District 4-H guest. After the banquet, the 4-H members headed to Capitol to debate and vote on the mock bills in the House of Representatives and Senate chambers. The 4-H youth completed the evening at the hotel with fun activities so they could gather and socialize.

On Monday morning, 4-H'ers attended a buffet breakfast and a presentation from Randy Watson, Kansas Commissioner of Education. Then, 4-H'ers headed back to the Capitol to meet with legislators, observe committee meetings, legislative sessions, and tour the Capitol and other activities. Snacks were available throughout the morning, followed by a boxed lunch for 4-H youth and legislators. This allowed for more opportunities to mingle and meet.

CIA was a great opportunity for our youth to witness the legislative process in action, participate in mock sessions, to promote 4-H to our legislators, and to learn the difference individuals can make within their state government.



Youth for the Quality Care of Animals—YQCA

Youth for the Quality Care of Animals (YQCA) is the livestock quality assurance program that is required to sell livestock in the premium auction at your local county fair and to participate in the Kansas State Fair Grand Drive or the Kansas Jr. Livestock Show.

YQCA training is offered in-person and online for all youth ages 7-19. All youth age 7 are required to attend the in-person training. The in-person training is \$3.00 per youth while the online training is \$12.00 per youth.

You must sign up for YQCA Training online at the following link www.yqca.org. Make sure to sign up using your 4-H Online account. YQCA is offering a test-out option only for youth 4-H age 12 and 15. The training must be completed online and cost for the multiple years in which they are testing out vary so prices are different for individuals.

Tractor Safety Course 2022

BY: National Safe Tractor and Machinery Operation Program

River Valley Extension District, Post Rock District, Central Kansas District, Midway District, Cottonwood District will be conducting the Hazardous Occupations Training/ tractor and machinery safety training. The Training provides trainees with knowledge of tractor, machinery, and other farm hazards to reduce the farm accident rate. It also provides sufficient information to pass a written examination and an opportunity to demonstrate their ability to pass a safe tractor driving examination. **Participants must be 14 or older to receive certification, though 12 and 13 year olds may take the course for education purposes only.**

Federal Law requires youth to participate in a Hazardous Occupations Training and become certified in order to work for hire for anyone other than their parents.

Don't forget to check your 4-H Online profile at v2.4honline.com before Sunday, May 1st to ensure the 4-H members in your family are enrolled in the correct projects. Please check to make sure that phone numbers, addresses and emails are correct also.

The projects that youth are enrolled in as of May 2nd are the projects eligible to participate in at the county fair. Do not wait to go in and double check, after the May 1st deadline, it will be to late.
